

C&A Field Day Athletics Waiver and Release of Liability

MUST READ BEFORE SIGNING

Field Day's primary goal is to have fun, and injuries are not fun. All participants must abide by the following rules to mitigate the risk of accident or injury.

All Participants agree to:

- Consult their physician before engaging in new activities.
- Listen to directions provided by C&A staff members.
- Use equipment in accordance with its intended purpose.
- Stretch and warm up before engaging in Field Day.
- Avoid unnecessary roughness during games.
- Not participate under the influence of drugs or alcohol.
- Not participate if doing so may worsen a previous injury or condition.
- Stay hydrated throughout the event.
- Not participate if they are currently pregnant.
- Remain within their physical limits. Go slower during games or take additional breaks if necessary.

If minors are participating, parents or guardians must:

- Remain present throughout Field Day.
- Ensure that minors understand and obey all rules.

Failure to follow instruction can result in dismissal from the games with no refund offered.

In consideration of being allowed to participate in any way in C&A Field Day athletic sports program, related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risks of injury and illness (ex: communicable diseases such as MRSA, influenza, and COVID-19) from the activities involved in this program are significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce these risks, the risks of serious injury and illness do exist; and,

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation; and,

3. I willingly agree to comply with the stated C&A Field Day rules and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,



4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS C&A Field Day, their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event ("RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
